| Why? | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. |
| What? | The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number • Account balances • Payment History • Credit card or other debts • Mortgage rates and payments When you are no longer our member we continue to share your information as described in this notice. |
| How? | All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Glendale Area Schools Credit Union chooses to share; and whether you can limit this sharing. |

| How does Glendale Area Schools Credit Union protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, secured files and buildings along with https protocol and utilization of session cookies to validate client sessions. |
| How does Glendale Area Schools Credit Union collect my personal information? | <p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • Open an account • Apply for a loan • Make a wire transfer • Give us your income information • Give us your contact information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p> |
| Why can't I limit sharing? | <p>Federal law gives us the right to limit only:</p> <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes- information about your credit worthiness, • Affiliates from using your information to market to you, • Sharing for non-affiliates to market to you. |

| <i>Affiliates</i> | <p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Glendale Area Schools Credit Union does not share with our affiliates. |
| <i>Non-affiliates</i> | <p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Glendale Area Schools Credit Union does not share with non-affiliates so they can market to you. |
| <i>Joint Marketing</i> | <p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • Glendale Area Schools Credit Union does not jointly market. |
